*In addition to tuition, all students in grades K5 – 12 must pay a \$375 student activity fee per Student.

*All families are responsible for purchasing or selling \$500 in tickets for the Cash Giveaway.

I hereby agree that in case of default in payment of any tuition/fees, the entire unpaid balance of this debt shall, at the option of The Lakeside School administration and/or officers, become immediately due and payable. I hereby agree to pay all costs of collecting, or attempting to collect or secure, tuition/fees due, including a reasonable attorney's fee, whether the same is collected or is secured by litigation or otherwise. I further understand this instrument will be interpreted in accordance with the laws of the State of Alabama.

I understand and agree that my obligation to pay tuition/fees for the full academic year, or portion of the year after the date of enrollment is unconditional unless the child/children are withdrawn, in writing, prior to **June 15, 2025**. I understand and agree that upon my withdrawal of the child/children after **June 15, 2025**, all tuition/fees are immediately due and payable on the date of withdrawal. I further understand that all tuition/fees are due and payable after **June 15, 2025** for my child/children should he/she/they be dismissed from The Lakeside School for any reason.

By signing this contract, I obligate myself for the entire tuition/fees amount specified above. I understand tuition paid monthly is due by the 1st of the month and must be received no later than the 10th of the month, according to the Payment Plan I have selected above. I also understand that when any payment is in arrears: **a \$50.00 late fee will be levied each month thereafter**, grades/report cards will not be issued, transcripts or records will not be released, participation in extracurricular activities will not be allowed, and child or children will not be accepted or renewed to the following school term. Any financial obligations (tuition, extended day, bus fee, lunchroom, class dues, etc.) that reach 60 days in arrearage may result in dismissal of the student or legal action. Participation in summer extracurricular activities will not be allowed until registration is complete and all financial obligations are paid in full. I also understand that if my child is a **Senior**, my account is due in full by **May 1, 2026**. In the event my account is not paid in full by **May 1, 2026**, I understand that my child may be prohibited from participating in the graduation ceremony.

The child/children's continued enrollment in The Lakeside School will be contingent upon the student's and the parent's/guardian's compliance with the policies and rules of the school as specified in the Student Handbook. The undersigned agrees to accept the rules, regulations, and policies of The Lakeside School and to support the educational philosophy, moral, dress, attendance, disciplinary, and other standards of The Lakeside School as stated in the Student Handbook and other school publications. Failure to support the standards of the school by the undersigned may result in dismissal of the student. The undersigned further agrees that this enrollment is contingent on the student's successful completion of the 2024-2025 academic year at the current school based on prevailing academic and disciplinary criteria as determined by The Lakeside School administration.

The Lakeside School retains the right to use any photography and video of school activities and students (both candid and pre-arranged) for promotional, publicity, advertising, and marketing purposes. No additional notification is deemed necessary with signing of this contract. By signing this contract, I also agree to allow the school to publish my names, address, and telephone number in the school directory.

I affirm that I am the parent or legal guardian of the listed child/children and said child/children resides in my household. I understand as the parent or legal guardian of the listed child/children that I am responsible for the fulfillment of any financial obligations even though another individual is providing payment or partial payment for the tuition. **I authorize The Lakeside School to release all information regarding my financial obligation to The Lakeside School as well as my child's/children's academic and behavior records to the following people:**
